Reporting

Racism, Discrimination, and Sexual or Racial Harassment

Orlando Repertory Theatre will strengthen internal organizational systems, processes, structures, and cultures that encourage any person to engage with us.

In an effort to reduce harm, create accountability, and correct behavior, we encourage our community to report any episode considered to be racism, discrimination, or sexual harassment. Each report will be reviewed by those on the Concern Resolution Path (CRP) to ensure that appropriate actions are taken.

Filing this report constitutes official notice to Orlando Repertory Theatre and may result in the institution commencing an investigation into the information and allegations contained within the report.

This report is NOT confidential. By submitting this report, the reporter understands that the report may be investigated and heard by appropriate parties of the Orlando Repertory Theatre staff and board for the purpose of determining its validity and the process forward. We recognize that this can be sensitive information and will be treated as such.

Definitions

Racism: A belief that race is a fundamental determinant of human traits and capacities, and that racial differences produce an inherent superiority of one race over another; also, policies or actions based on this belief.

Harassment: Harassment is unwelcome conduct that is based on race, color, religion, creed, national origin, ancestry, sex (including pregnancy), gender (including gender identity, gender nonconformity and status as a transgender individual), sexual orientation, age, physical or mental disability (including mental illness), citizenship, or any other characteristic protected under the law ("protected characteristics").

Discrimination: Unfair or unfavorable treatment based on a protected characteristic.
